聯合國消除對婦女歧視委員會 將於明天審議香港及中國人權狀況 公眾可收看直播

聯合國消除對婦女歧視委員會(委員會)將於香港時間明天(5月12日)下午4時舉行會議·審議香港及中國在實施《消除對婦女一切形式歧視公約》(《公約》)方面的情況。

屆時,委員會將根據政府早前提交的國家報告,以及其他公民社會團體提交的人權報告,詳細 審議香港及中國在保障婦女權利方面的狀況。委員會完成審議後,會按觀察所得發表審議結 論,詳述委員會的關注,並對香港與中國政府提出改善建議。

UN Committee to hold meetings tomorrow To discuss human rights situation in Hong Kong and China Livestream is available

The United Nations Committee on the Elimination of Discrimination against Women ("Committee") will hold meetings tomorrow (12 May) at 4 p.m. (Hong Kong time) to discuss the human rights situations regarding women in Hong Kong and mainland China.

By considering the State reports submitted by the governments, along with the parallel reports and information provided by civil society organisations, the Committee is going to discuss and raise questions on the implementation of the Convention on the Elimination of All Forms of Discrimination against Women in Hong Kong and mainland China.
